**NOTICE OF MEETING OF BOARD OF DETERMINATION**

Notice Is Hereby Given to you as a person liable for an assessment that the Board of Determination, composed of Al Boggs, Ken Mitchell, Ted Dusseau, or alternate will meet on **Tuesday, April 19th, 2016, at 7:00 o'clock in the evening at the Woodstock Township Hall, 6486 Devils Lake Highway, Addison, MI, 49220**, to hear all interested persons and evidence and to determine whether the drain known as the Echo Cove Drain is necessary and conducive to the public health, convenience or welfare, and whether said maintenance and improvement is necessary for the protection of the public health in the following municipalities: Woodstock Township, pursuant to Chapter 4 of Public Act 40 of 1956, as amended.


Your petitioners further show that the said drain needs and asks you to locate, establish and construct a drain or drains, or any portion thereof, which will properly drain the lands in the district, under the provision of Act No. 40 of the Public Acts of 1956, as amended. The location of the drain, or drains, or any portion thereof, are as given in your Order for Laying Out and Designating the Echo Cove Drain Drainage District to substantially as follows:

Located in Section 35, Woodstock Township, T-5-S, R-1-E Lenawee County, Michigan, to provide adequate drainage relief to the roads, parcels and adjoining parcels to the Plat of Echo Cove.

Proceedings conducted at this public hearing will be subject to the provision of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the County Drain Commissioner.
