Parks Community Asks Survey



The following report provides an **analysis of resident feedback collected in a Community Asks survey** designed by Zencity and deployed by Lenawee County, to learn about residents preferences regarding the county parks. The survey collected **139 responses** between June 12-July 5, 2023, encompassing two-closed ended question.

The following is a breakdown of residents responses:

In the past 6 months, which of the following Lenawee County, MI parks have you visited?

136 of 139 people answered this question

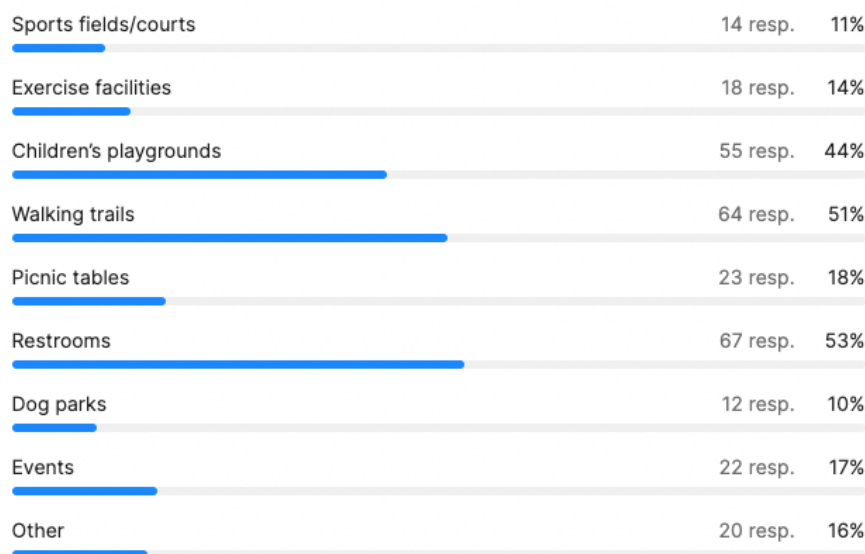


Note: This is a multi-select question, so the sum of the percentages may be greater than 100%

Most respondents **had not visited the above-listed parks (72%)** in recent months. Among those visited, Bicentennial, Taylor Road, and Gerber Hill collected the most responses.

Which of the following would you most like to see improved or added to Lenawee County, MI Parks?

126 of 139 people answered this question

The main improvements selected by respondents were **restrooms, walking trails** and **children's playgrounds**, and to a lesser extent, **picnic tables**.
