LENAWEE COUNTY DISTRICT COURT COMMUNITY SERVICE WORK PROGRAM

You have been ordered to complete community service work as a term of probation, or in lieu of paying fines and costs. This must be completed at a **NON-PROFIT** agency.

Attached is a listing of community service work placement agencies in the Lenawee County area, and the contact person with a phone number and address (if available).

It is your responsibility to make contact with the agency where you wish to complete your community service work and set up a work schedule with the contact person.

Once this schedule has been set up, you are to notify your probation officer with the name of the agency, contact person, and the date that you are to begin your community service work.

Please be reminded that you are to treat your community service work just as you would a regular job. If there is an emergency and you cannot report for work as scheduled, you are to call the agency and notify them of the circumstances.

Please note that these hours are to be completed in a **TIMELY MANNER**.

If you fail to report as scheduled or fail to complete the hours in a timely manner, your paperwork can be returned to your probation officer, which may result in a violation of probation resulting in a court hearing or possible jail sentence.

There may be an agency that is not listed where you may prefer to complete your community service hours. For example: Any local school district, any local church, any city township, or any other non-profit service organization. Follow the same procedure as above but be sure to clear the agency with your probation officer first.

If there are any questions or problems that arise, contact your probation officer **IMMEDIATELY**.
