WHEREAS, an application, dated March 13, 2018, has been made and filed with me, the Lenawee County Drain Commissioner, for the Laying Out and Designating of a Drainage District; and

WHEREAS, the County Treasurer has provided a statement that less than 33 1/3% of the lands in the proposed drainage district owe taxes and special assessments over the preceding three years; and

WHEREAS, I retained **Eng Inc. 4063 Grand Oak Drive, Lansing, MI 48911** to perform a survey of the proposed drain and drainage district.

NOW, THEREFORE, I do hereby determine:

1. The name of the drain is the Yankee & Silberhorn Drain.
2. The Drainage District boundaries are as described in the attached *Exhibit B*.
